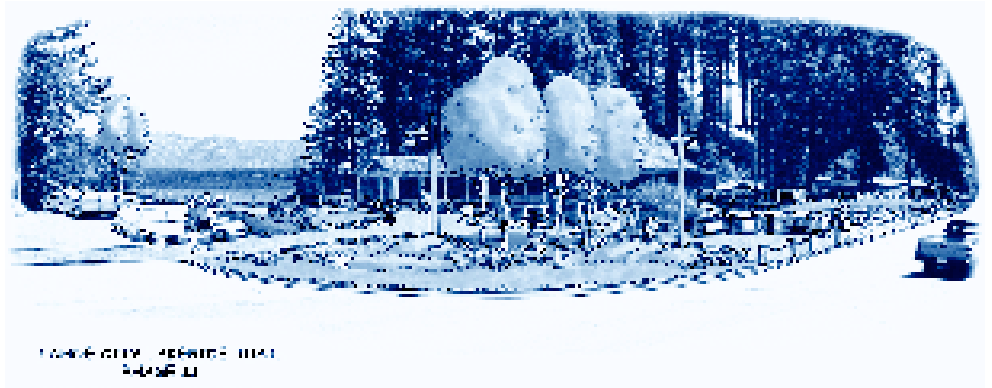

# NEW YEAR'S STORM TESTS EMERGENCY PROCEDURES

With heavy winds, and torrential rains, New Years 2006 came in with an un-welcomed bang. Power outages, mudslides and flooding created a nightmare for many residents and visitors. These situations called for quick emergency response from TCPUD employees and management.

The TCPUD water and sewer system's 35 pump-and-lift stations depend upon reliable power. The 18 primary stations have integrated back-up generators that ensure uninterrupted service. The smaller stations require staff to move portable generators into place when needed. All of the generators require refueling, and in the midst of storms, monitoring stations, moving generators, and refueling become extremely complicated and arduous tasks.

With so many employees living outside the Tahoe Basin, mudslides, flooding, and

highway conditions often restrict the number of personnel available to respond quickly. During this storm TCPUD has assistance from a local contractor who left his home and family to help.

Although TCPUD was able to keep water service intact to all of our customers and did not have any sewer overflows, we ask homeowners consider taking the following precautions during major storm events and/or power outages to maintain your safety and the protection of the environment:

- Conserve water usage and reduce wastewater production. *Remember that even if you have electrical service, the water and sewer pump stations may not.*
- Install at least one plug-in phone so that even in power outages you'll have phone service
- Maintain a battery-operated radio and tune to KTKE 101.5 FM, KOWL 1490 AM, or KTHO 590 AM, local radio stations for emergency notification and information

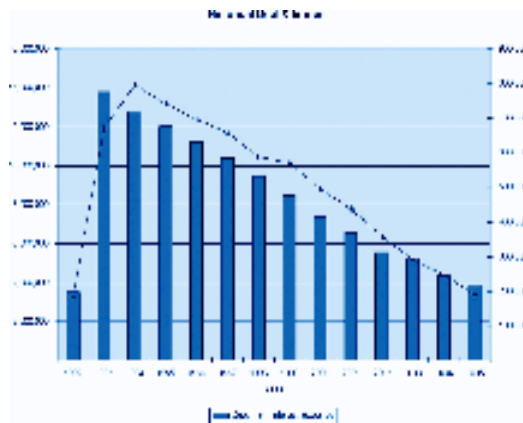
## AFFIRMATIVE REPORT FROM THE AUDITORS

At their March meeting the TCPUD Board received the annual independent audit report on TCPUD's general-purpose financial statements from McClintock Accountancy Corporation. The District's financial statements once again received an unqualified or "clean" opinion. The annual financial audit is required by state law of all public agencies to safeguard public funds through independent evaluation.

Financial highlights for 2005 include reducing total debt and capital leases out-

standing to \$3.8 million – the lowest level since March 1993. In addition, as of December 31, 2005, the District has reserves of \$900,000 for long-term capital replacement, \$500,000 for emergencies, \$250,000 for annual cash flow fluctuation requirements, and \$200,000 for post-employment medical benefit programs.

## Truckee River Trail Summer 2006 Closure

The Truckee River Bicycle Trail between Midway Bridge and Squaw Valley Rd was washed out during the Jan 1st - 3rd, 2006, rainstorms. The magnitude of the repairs and challenges of the location will require trail closure for most of the season.

Repairs will start as soil conditions allow. The District is under contract with FEMA for public assistance in repair cost recovery. The State of California Dept of Transportation will provide an alternate route for pedestrians and bicyclists along the southbound shoulder of Hwy 89 between Squaw Valley Rd and Midway Bridge.
