Water Conservation Tips – Save Water, Save Energy

One of the easiest ways to help conserve our natural resources is to practice water conservation. Please do your part to conserve water and the energy used to deliver it to you!

LANDSCAPING – OUTDOOR USE

- Do not water native landscape or open lots
- Water in early morning or evening
- Do not over-water landscaping
- Check sprinklers often so that water is directed where necessary
- Wash cars with bucket & hose with shutoff nozzle
- Do not hose down sidewalks or driveways

- Mulch around trees & plants
- Plant drought-tolerant trees & plants

INSIDE USE

- Do not leave water running while brushing teeth, shaving, washing dishes, cleaning produce, or defrosting food
- Repair leaking or running toilets
- Wash only full loads of laundry or dishes
- Install water-saving showerheads & toilets
- Take shorter showers
- Detect leaks & repair them within 48 hours ■

Understanding park use will assist TCPUD in planning and funding for future improvements at the facilities. It will also help assess the success or needs of our current operational strategy. TCPUD 2005 Construction Projects

West Shore Bike Trail Improvements at Sequoia Crossing

Construction on the long-awaited trail improvements at “Sequoia Crossing” began in early June and should be complete by mid-August. Since the early 1990’s, TCPUD has been working to find a solution to the bike trail’s dangerous surface crossing located between the intersections of Sequoia Drive and Highway 89. Five different alternatives were evaluated for safety needs, environmental impacts, private property impacts, user practicality, and cost. The alternatives were narrowed to the final approved project, which includes:

- An automated vehicle warning system with flashing lighted signs;
- Improved sight distance for vehicles and trail users through hillside changes and stabilization;
- Elimination of the steep grade of the trail just north of the crossing, and replacement with a gradual climb.

While construction is underway, Caltrans officials have worked with TCPUD staff to provide an interim alternative that will allow trail users to walk along the east side of the highway. Delineators and signage will direct trail users to the alternative. Trail users and vehicles are asked to use caution through this area.

Highlands Area New Water Facilities

TCPUD and the Tahoe Truckee Unified School District are undertaking the construction of a new water tank, booster pump station, and service line in the Highlands area. The new 1.2 million gallon tank will provide adequate water supply and pressure to meet new code requirements for the North

Tahoe Middle/High School project. The supply and pressure improvements will also benefit many of the residences in the area. TCPUD and TTUSD are sharing the costs of the project. TCPUD is the lead agency on the project. Construction is expected to be complete in July of 2006.

Chambers Interim Water Treatment System

Beginning in June, TCPUD will reactivate the interim water treatment system serving the McKinney area. This system augments the well supply serving this region. TCPUD will continue to evaluate potential permanent solutions. Residents are encouraged to conserve water, especially during peak use times of the summer months. ■

Dogs on the Beach

Most of the public beaches at Lake Tahoe prohibit dogs. The various agencies that own public lands have different regulations. TCPUD operates beaches for Placer County and California State Parks. These agencies prohibit dogs on their beaches.

TCPUD would like to remind dog owners of the reasons behind these regulations, which include:

- Public safety
- Protection of Lake Tahoe’s water quality
- Protection of wildlife

Please keep your dog leashed on our trails and in our parks where they are allowed.

The only beach within TCPUD’s boundaries that allows dogs is located 1/2 mile south of Tahoe City and is operated by the United States Forest Service. Dogs must be leashed and dog owners are strongly encouraged to clean up after their dogs. ■
