### TCPUD LAUNCHES NEW WEBSITE

### 2018 CAPITAL PROJECT UPDATE

**Bunker Tank Replacement** – Work will resume on this project in May, weather and conditions permitting. Last fall the site work and service infrastructure were mostly completed with tank construction scheduled this summer. The current tank, built in 1960, is 500,000 gallons and does not have required seismic protection. The new tank will be 1.2 million gallons, more than two times the current size, and be built of steel construction meeting all seismic requirements.

**Truckee River Bike Trail Pavement Rehabilitation** – TCPUD will begin the replacement of the Truckee River Trail this summer. Project activities will begin on or after May 1 and continue through August 17th. During this time there may be short detours but the trail will remain open for use. The trail will be CLOSED from August 18th through project completion, which is anticipated to be October 2018. **Madden Creek and Tahoe Cedars Interconnections** – TCPUD is finishing the planning and design of interconnections that will connect the Madden Creek and Tahoe Cedars Water Systems to the McKinney Quail Water System. These connections will provide both Madden Creek and Tahoe Cedars with a dedicated back up water source and access to increased storage for fire protection.

### OTHER AGENCY PROJECTS

**State Route 89/Fanny Bridge Project** – Construction is scheduled to begin May 1 (weather dependent). In 2018, it is anticipated that the new Truckee River Bridge, new SR 89 alignment, and roundabouts located at either end of the new alignment will be constructed. Following the new SR 89 alignment, a new roundabout at the “wye” will be completed along with the replacement of Fanny Bridge.

**Sugar Pine to Meeks Bay Bike Trail** – The California Transportation Commission has approved funding in order to construct the extension of the West Shore Bike Trail to Meek’s Bay. Construction is slated to start in summer 2018.

Did you know that Commons Beach and Skylandia Park are available for private rental? And that’s not all! Nearly all of TCPUD’s parks and facilities are available for rent. A private room rental in the Fairway Community Center starts at just \$12/hr, tennis courts at Kilner Park are just \$9/hr, or rent one of the numerous sports fields for a family reunion softball or soccer game. From meeting space to wedding venues and everything in between, TCPUD has the space you need at rates that can’t be beat.

Due to popular demand, TCPUD has added another kayak/paddle board rack at Lake Forest Beach. First come, first served reservations for these new spaces or any available spaces at Commons Beach and Skylandia Park are open to residents on April 16th. ## TAHOE CITY GOLF COURSE CELEBRATES 100 YEARS!

At the turn of the century, a railroad spur line brought guests to the Tahoe Tavern in Tahoe City. As the Tavern and the sport of golf gained popularity, a portion of the Tavern's extensive holdings were set aside for a golf course. The Tahoe City Golf Course, commissioned in 1917 by the Tahoe Tavern, was designed by May "Queenie" Dunn Hupfel who also served as pro and manager after the course opened in July of 1918. First built as a 6-hole course with sand greens, the Tavern Links became nine holes and 2,700 yards in 1926.

Through several sales of the Tahoe Tavern, its outlying and separately deeded parcels were divided up among the partners. Thus, the Golf Course became the property of Gordon and Pat Hyde in 1946. Just two years later in 1948, the Hyde's sold to Carl Bechdolt, Jr. and wife Elsie. The course remained with the Bechdolt family until February 2012 when a consortium of public agencies led by the Tahoe City Public Utility District purchased the course, converting it into a public municipal course for the enjoyment of the community and its visitors.

### Water Conservation... It's a Way of Life.

As of the publishing of this newsletter, the State has not yet made any official determination regarding mandated conservation or other water saving measures. Regardless, TCPUD and the State of California are striving for a consistent, protective attitude toward our water resources. Unless the state takes a position on new mandates or regulations, TCPUD will continue to implement Stage 2 regulations. These regulations are common sense and always good practice. They include prohibiting: water runoff, using water on hard surfaces and non-recycling water features. There are no mandated water use requirements at this time, but water leaks are required to be repaired within ten (10) days of notice.
