Senior Civil Engineer Improvements – **Notice of Award**

RECOMMENDATION: District staff recommends that the Board of Directors take the following steps to proceed with this project:

1. Based on the Total Bid Price, which is the sum of the Base Bid + Bid Alternate, identify the three low bidders as:

#1.	McCuen Construction, Inc.	\$ 532,796.00
#2.	Herback General Engineering	\$ 608,863.80
#3.	Biondi Paving, Inc.	\$ 786,670.00

- 2. Approve that the District enter into a contract to be executed by the General Manager with the lowest responsive bidder **McCuen Construction**, **Inc.** for the Total Bid Price amount of \$532,796.00.
- 3. Amend the 2018 Parks Capital Budget to include an additional \$238,600 for the project.

BACKGROUND: Based on the proximity and similarity of proposed work, District staff added improvements from a separate Parks Capital project into the TCGC Upper Parking & Maintenance Area BMP Improvement Project bid package. The Bid Alternate specifically addresses drainage rehabilitation along the TCGC 5th Fairway that is budgeted for in the Tahoe City Golf Course/Tahoe City Winter Sports Park Drainage Repairs and Rehabilitation Project.

Bid proposals were received and opened for the above-referenced project on Wednesday, July 25, 2018 at 11:00 am. Five (5) bids were submitted and the results are listed below.

The Engineers Estimate for the Base Bid plus Bid Alternate is \$547,179.

The estimated \$238,600 total expenditure over the approved total Capital Budget is primarily attributed to the following additions/modifications associated with the project.

- Additional excavation/disposal of unsatisfactory soils.
- Import/replacement of over-excavated soils.
- Additional permit and approvals processing with North Tahoe Fire Protection District, Placer County, and TRPA.
- Inclusion of improvements previously associated with the Tahoe City Lodge development to facilitate NTFPD approval.
- Alternative design efforts associated with easement re-alignment negotiations.
- Coordination with TCGC M&O architect and preparation of site design alternatives.

Staff is recommending that this amount be designated from the 2018 Parks Capital Budget based on anticipated available funds from other projects.

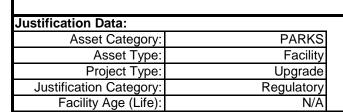
Project Description:

Install erosion control and drainage measures at Tahoe City Golf Course, including new paving of unpaved areas, repaving existing roadway and parking lot, all to reduce soil runoff into the Tahoe watershed. Utility relocations and servicing for the proposed M&O building (separate project) will also be installed with this Project prior to asphalt placement.

Justification or Significance of Improvement:

This work is a TRPA requirement and will help with lake and river clarity. The parking lot pavement improvements will improve aesthetics and safety, as well as vehicle flow through the facility. It will also provide more structured parking.
