PASS HOLDER AGREEMENT: I understand that season passes are non-transferable and non-refundable. I agree to comply with all rules and regulations of the Tahoe City Winter Sports Park (TCWSP). Failure to abide by the rules and regulations will render my pass subject to immediate cancellation. I understand that passes are based on the operating season of the park, November - March in a calendar year and that there are no guarantees with regards to the number of operating days for the park or any of its activities. I agree to comply with the park's policy that activities may only occur during regular, posted hours of operation.

TERMS & CONDITIONS: TCWSP shall have the right to suspend or terminate the privileges of any pass holder, without refund, if the pass holder or the pass holder's guest engages in conduct that is deemed by TCWSP to be likely to endanger the welfare, safety, harmony, or good name of TCWSP or its guests or that is otherwise improper or illegal. TCWSP shall be the sole judge of what constitutes improper conduct, but improper conduct shall include (i) violating park rules; (ii) damaging, destroying or stealing property of TCWSP or of guests or employees of TCWSP; (iii) failing to pay amounts owed to TCWSP in a timely manner; and (iv) abusing, threatening, or harassing guests or employees of TCWSP. TCWSP shall not be responsible for loss of or damage to any personal property used or stored at TCWSP facilities.

WAIVER OF LIABILITY

Any person using these facilities understands it involves risk and acknowledges and understands that he/she is using the facilities and services of TAHOE CITY PUBLIC UTILITY DISTRICT, dba TAHOE CITY WINTER SPORTS PARK (TCWSP) at his/her own risk. Any person using these facilities or participating in activities such as but not limited to: ice skating, sledding, snowbiking, cross country skiing or snowshoeing assumes all risks and dangers and all responsibility for any losses and/or damages whether caused in whole or in part by the negligence or the conduct of the representatives, employees, or volunteers of TCWSP or by any other person.

The TCWSP and their officers, employees, agents, contractors and affiliates shall not be liable -- and any person using these facilities, their personal representatives and their heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify TCWSP and its representatives, employees, and volunteers from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of any equipment or participation in these activities.

Any person using these facilities specifically understands that he/she is releasing, discharging, and waiving any claims or actions that they may have presently or in the future for the negligent acts or other conduct by the representatives, employees, and volunteers of TCWSP.

DOG OWNERS

As a dog owner I agree to respect the following guidelines when skiing or snowshoeing with my dog at the Tahoe City Winter Sports Park:

- Leashes are required at the trailhead and parking lot.
- Dogs are not allowed in the day lodge, except for service dogs.
- Always clean up after my dog. Poop bags are provided free of charge.
- Please place all doggie bags in the garbage cans placed along the trail.
- Stay on designated dog trails only.
- Keep your dog close to you and under voice command.
- Skijoring, being pulled along by a harnessed dog, is not allowed at the Tahoe City Winter Sports Park.
- Dogs are not permitted on the sled hill or ice rink.
- Please leave aggressive and unruly dogs at home.

MEDICAL RELEASE AND PERMISSION TO TREAT A MINOR
