PUBLIC HEARING DATE SET FOR 2019 WATER AND SEWER RATE STUDY

In early 2019, the TCPUD Board of Directors initiated a comprehensive 5-year Water and Sewer Rate Study (2019 Rate Study) to establish an equitable and cost-based water and sewer rate structure. The 2019 Rate Study also identified the revenues necessary to sufficiently fund water and sewer operations and capital infrastructure needs throughout the TCPUD service area over the next 5 years.

As a commitment to open communication and transparency in the rate setting process, TCPUD held numerous public meetings to solicit public comment this summer. Following this extensive outreach, the TCPUD Board authorized the proposed 5-year water and sewer rate plan at the August 16, 2019 Board meeting, and set a Public Hearing for Friday, October 18, 2019 at 9am during a regularly scheduled Board meeting. All impacted customers were notified by mail of the proposed 5-year water and sewer rate plan and invited to attend this Public Hearing.

AWARD WINNING DISTRICT

Additionally, TCPUD was awarded the Government Finance Officers Association of the United States and Canada *Certificate of Achievement for Excellence* in Financial Reporting for its 2018 Comprehensive Annual Financial Report. This was the second consecutive year that the TCPUD has achieved this prestigious award.







YOUR TAX AND RATE DOLLARS AT WORK

Significant capital investments are planned in the next several years. Below is a snapshot of a few capital improvement projects.

WEST LAKE TAHOE REGIONAL WATER TREATMENT

PLANT Construction of a permanent, year round drinking water treatment plant is planned to replace the temporary seasonal treatment plant located at Chambers Landing. The new water treatment plant will provide a reliable, drought-resistant, and safe drinking water source to TCPUD's West Shore service area. Pending final design and permitting, TCPUD is targeting a 2020 start of construction for this \$14 million dollar capital improvement project. TIMBERLAND WATER SYSTEM IMPROVEMENT PROJECT

In June 2019, TCPUD began construction on the full replacement of the Timberland Water System to improve the distribution, servicing, and fire suppression capabilities of the system. This estimated \$3.7 million capital improvement construction project is planned for two phases. The first phase is scheduled to finish this fall, with the second phase scheduled for construction in 2020. For more information and to view project area maps, visit: tcpud.org/timberland

MADDEN CREEK WATER SYSTEM IMPROVEMENT PROJECT

In July 2019, the Madden Creek Interconnection and Distribution Improvement Project began construction to provide backup water supply and additional water storage for the Madden Creek Water System. Similar to the Timberland project, it has been divided into a twophased construction schedule. The first phase includes the McKinney-Quail interconnection and associated high pressure transmission line replacement. TAHOE CITY GOLF COURSE IMPROVEMENTS As the TCPUD's 4th season of direct operations of the Tahoe City Golf Course winds down, the conditions are at an all-time high. TCPUD has implemented a number of course improvements including investment in over 40 new sprinklers to improve water distribution and conservation, equipment upgrades to ensure quality conditions of the greens and fairway, enhanced bunkers and cart paths, new hitting area, and ongoing drainage upgrades that will continue this fall. In recognition of recent course improvements, the Tahoe City Golf Course was recently awarded second place in the 2019 Sierra Sun Best of North Lake Tahoe and Truckee Readers Poll.

PARKS UPDATES

Bike Trail Surveys On August 7 and 8, 2019, TCPUD staff and volunteers administered over 300 surveys and counted over 4,000 trail users at four stations across TCPUD's 23-mile trail network. The annual trail surveys collect important feedback to improve the trails and user experience and is critical to secure future grant funding opportunities. New survey questions were added this year to learn about winter trail use and electric "E-bikes." 76 percent of survey respondents reported that they have, or would consider, using the trails in the winter, and 11 percent of survey respondents reported using E-Bikes – which are allowed on the trails.
