Face Coverings

The CA Department of Public Health recently released new guidelines for face coverings. Read the new guidelines [here](#).

As of 6/15, 2021 face masks are not required to be worn by participants at TCPUD outdoor camps and programs. In general, per CDPH, unvaccinated children and youth do not need to wear a mask outdoors, even if they cannot maintain physical distancing. However, per [CDC recommendations](#), in areas of [substantial to high transmission](#), people who are not fully vaccinated are encouraged to wear a mask in crowded outdoor settings or during activities that involve sustained close contact (including high-risk contact sports) with other people who are not fully vaccinated.
