**BENEFITS:** Golf passes include: a 20% discount on non-sale items in the pro shop, and access to member specials throughout the season.

**TEE TIME POLICY:** Pass holders may make advanced tee times up to seven days prior to play. Advanced tee times are NOT available June 29 – July 7, 2019.

**PASS HOLDER AGREEMENT:** I understand that season passes are non-transferable and non-refundable. I agree to comply with all rules and regulations of the Tahoe City Golf Course (TCGC). Failure to abide by the rules and regulations will render my pass subject to immediate cancellation. I understand that passes are based on the operating season of the course, spring – fall in a calendar year. I agree to comply with the course's policy that play may only occur during regular, posted hours of operation.

**TERMS & CONDITIONS:** TCGC shall have the right to suspend or terminate the privileges of any pass holder, without refund, if the pass holder or the pass holder's guest engages in conduct that is deemed by TCGC to be likely to endanger the welfare, safety, harmony, or good name of TCGC or its guests or that is otherwise improper or illegal. TCGC shall be the sole judge of what constitutes improper conduct, but improper conduct shall include (i) violating club rules; (ii) damaging, destroying or stealing property of TCGC or of guests or employees of TCGC; (iii) failing to pay amounts owed to TCGC in a timely manner; and (iv) abusing, threatening, or harassing guests or employees of TCGC. TCGC shall not be responsible for loss of or damage to any personal property used or stored at TCGC facilities.

**WAIVER OF LIABILITY**

Any person using these facilities understands it involves risk and acknowledges and understands that he/she is using the facilities and services of TAHOE CITY PUBLIC UTILITY DISTRICT, dba TAHOE CITY GOLF COURSE (TCGC) at his/her own risk. Any person using these facilities assumes all risks and dangers and all responsibility for any losses and/or damages whether caused in whole or in part by the negligence or the conduct of the representatives, employees, or volunteers of TCGC or by any other person.

The TCGC and their officers, employees, agents, contractors and affiliates shall not be liable -- and any person using these facilities, their personal representatives and their heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify TCGC and its representatives, employees, and volunteers from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of any equipment or participation in these activities.

Any person using these facilities specifically understands that he/she is releasing, discharging, and waiving any claims or actions that they may have presently or in the future for the negligent acts or other conduct by the representatives, employees, and volunteers of TCGC.

**MEDICAL RELEASE AND PERMISSION TO TREAT A MINOR**
